PANEL A: Insolvency and Family Law - Can They Coexist Fairly?



The Honourable Fred Myers, Ontario Superior Court of Justice

Mr Justice Fred Myers is a Judge on the Ontario Superior Court of Justice. Prior to his appointment in 2014, Fred was a partner at Goodmans LLP and, before that, at Osler Hoskin & Harcourt LLP. Fred was recognized as a senior commercial litigator in insolvency and corporate restructuring cases. Fred graduated from Osgoode Hall Law School in 1983 where he was awarded the Gold Medal. He served as law clerk to the Right Honourable Bora Laskin, Chief Justice of Canada and the Hon Mr Justice G E LeDain. In 1985, Fred obtained an LLM degree from Harvard Law School.

Robert Klotz, BSc, JD, LLM, was called to the Ontario bar in 1981. He practices in the Toronto firm of Klotz Associates, focusing primarily in bankruptcy and insolvency and commercial litigation.
