# PANEL Y: Canada North: Deemed Trust v. Priming Charges



# The Honourable Mark Schrager, Cour d'appel du Québec

Mr. Justice Mark Schrager was appointed to the Québec Court of Appeal on June 13, 2014, after serving on the Québec Superior Court from February 2011.
