# **Chair's Message**



As the holiday season approaches and 2023 draws to a close, it's astonishing how quickly time has passed. I am thrilled to begin my tenure as the new Chair of CAIRP, a role I accept with both honour and privilege. The transition has been seamless, a testament to the dedication and excellence of our CAIRP team, our committed volunteers, and the steadfast leadership of the Board and the Executive Committee both past and present. We have hit the ground running, and we've already begun making strides. So, without further ado, let's dive into it.

At the CAIRP Annual General Meeting on September 14, 2023, I briefed members on <u>CAIRP's 2024 – 2028 Strategic Plan</u> and I am

pleased to report CAIRP is well underway with its efforts to meet the goals set out in the ambitious plan. On the priority of delivering best-in-class professional education, I am pleased to advise that all students have now been moved over to the renewed CQP. The CAIRP Board of Directors received a demonstration of the revised online program and we were impressed with the quality of the program and the tools put in place to assist the candidates. CAIRP had a busy fall addressing a number of developments in the insolvency marketplace. In this regard there are a number of updates on insolvency industry issues which we want to bring to your attention including the following:

## Forms 31, 65, 78, 79

The OSB undertook a consultation on Forms 31, 65, 78 and 79 last fall and CAIRP provided its submission on November 2, 2022. It has taken the OSB some time to draft revised forms and in late August 2023, they provided CAIRP with a draft for review. CAIRP came back with further feedback to address problematic areas and the feedback was well received. The OSB will be issuing the Forms Directive and Guidelines in the next few weeks. Based on their current timeline, the new forms will likely go into effect by early summer 2024. Our thanks to the Consumer and Corporate Practice Committees for their efforts on this matter.

## Surplus Income Issue

Work continues on the Surplus Income Directive. The Surplus Income Working Group, which was struck by the OSB and includes five CAIRP member representatives from across the country, has met several times over 2023. Most recently they met on October 23, 2023 with Superintendent Lang joining the discussion. One more meeting is being scheduled early in the new year. Next steps include the finalization of recommendations by the OSB along with the preparation of a draft directive with a view to launching public consultations in January/February in anticipation of a final Directive to be published in Spring/Summer 2024.

# LIT Renumeration (Tariff) Issue

The Tariff Review Task Force and the Consumer Practice Committee have almost concluded their work. A draft submission is being finalized and once signed off will move forward to the CAIRP Board of Directors for approval. Our thanks to all the members engaged on this important issue as well as those who have been providing input.

## **Debt Advisory Marketplace**

As part of CAIRP's efforts regarding the unregulated Debt Advisory Marketplace, the OSB and CAIRP issued a joint <u>Consumer Alert</u> on debt-relief scams. The release obtained good pickup across the country as you can see in the "Media & Communications" section of the newsletter.

The OSB issued a <u>position paper</u> on December 7, 2023 entitled *The Adverse Effects of the Debt Advisory Marketplace on the Insolvency System.* Members may recall the Superintendent referenced the creation of the position paper in her appearances at the CAIRP Forums this past spring and at the Exchange and CAIRP's AGM in September. CAIRP is interested in hearing any feedback from members on the position paper. Please send your comments to info@cairp.ca.

#### **Underused Housing Tax**

Since February 2023, CAIRP has been working with the OSB to obtain clarification from the Canada Revenue Agency (CRA) on the application of the Underused Housing Tax Act (UHTA) and UHT requirements specifically for LITs. A meeting was convened with CRA, OSB and CAIRP on September 25, 2023 and the CRA committed to providing written clarification following a review with their legal team which we have now received and is available <a href="here">here</a>. Just a reminder that on October 31st, 2023, the CRA further extended the period to file a return and pay the Underused Housing Tax (UHT) for the 2022 calendar year without penalties or interest to April 30, 2024. As per <a href="CRA's notice">CRA's notice</a> issued on October 31, a separate return will have to be filed by April 30, 2024 for each residential property owned on December 31 of the 2022 and 2023 calendar years to avoid penalties and interest. # Bill C-280 (the Fresh Produce Protection Act or "FPPA")

Another Private Members' Bill, Bill C-280, entitled *An Act to amend the Bankruptcy & Insolvency Act & the Companies' Creditors Arrangement (deemed trust perishable fruits & vegetables)* (the "Fresh Produce Protection Act" or "FPPA") is moving quickly. The Bill has been passed by the House of Commons and is currently in second reading within the Senate. CAIRP has sent a submission addressed to the Chair, Standing Committee on Banking, Commerce and the Economy in the Senate along with a request to appear when the Bill reaches the committee for review following completion of the second reading. A copy of the submission has also been sent to Superintendent Lang and ISED. The submission can be found here.

#### Interventions - Poonian et al. v British Columbia Securities Commission

CAIRP was granted intervenor status by the Supreme Court of Canada on the Poonian file and prepared the <u>Factum</u>, which was submitted on October 10, 2023. The case was heard on December 6, 2023 and we await the court's decision. Our thanks to Gowling WLC (Canada) and specifically Haddon Murray and Heather Fisher for representing CAIRP on this matter. # **Financial Literacy Month**

CAIRP and the OSB issued a joint <u>Consumer Alert</u> on November 14th to help Canadians identify and avoid debt-relief scams, and to provide them with information on LIT services and how to find an LIT on the OSB's and CAIRP's websites. # **Education**

We are pleased to share that, as part of the CQP renewal, CAIRP recently launched the new Insolvency Principles, Processes and Practice (IP3) course. This course builds on the Introduction to Insolvency course that was launched in April this year. It will equip candidates with the technical knowledge required as an entry-level CIRP and illustrate how to apply that knowledge to both consumer and corporate settings. We have also successfully transitioned all students from the legacy program to the renewed CQP. The final course, Applications in Insolvency & CNIE Prep ("AICP"), will be launched in 2024.

On the Core Knowledge Exam (CKE) front, the October exam was written by 32 English candidates and 6 French candidates. The results have been distributed to candidates. The Competency-based National Insolvency Examination (CNIE) was written on November 15 and 16 by 35 candidates – 26 English and 9 French.

If you have any staff or know anyone interested in pursuing the Practical Course in Insolvency Counseling (PCIC), now is a great time for individuals to register in preparation for the next examination, which will be held on **February 8**, **2024**. To write the exam, students must complete all Competency Assessments, achieving a minimum of 60% on each and submit their exam application online. An exam information package will be sent to all registered writers after the exam registration deadline has passed (after January 12, 2024). If you know of anyone interested in the course, please direct them to our website, or contact Benjamin Lecointre.
