## CIF ANNOUNCES LLOYD HOULDEN RESEARCH FELLOWSHIPS

he Canadian Insolvency
Foundation (CIF) recently
announced the 2012 winners
of the Lloyd Houlden Research
Fellowship. They are **Professor M. Gordon Hunter** of the University
of Lethbridge and **Professor Nick Milanovic** of Carleton University.

of this year's winners. "I am very encouraged by the quality of applications we received again this year. I think that both of our recipients will make a meaningful contribution to insolvency

research through the papers they will present."

CIF is a not-for-profit organization founded by the CAIRP with membership drawn from all stakeholders in the insolvency community. It is dedicated to research and education related to insolvency and bankruptcy legislation and practices, both corporate and personal, and to the skills of restructuring, refinancing, corporate rescues and turnarounds.

Dr. M. Gordon Hunter is Professor of Information Systems in the Faculty of Management at The University of Lethbridge, in Alberta, Canada. He has also been appointed Visiting Professor at the Faculty of Business, Computing and Information Management, at the London South Bank University. Professor Hunter has previously held academic positions at other universities in Canada, Hong Kong, and Singapore.

His research paper will identify issues surrounding the insolvency process related to small businesses. Each year 139,000 new businesses are formed in Canada, with about 30% failing within one year, and with only 25% still in operation after 9 years. Given these statistics the question arises, what are the issues involved in the small business insolvency process? Are there common issues surrounding these processes? Can factors be identified that will assist insolvency professionals?

Nick E. Milanovic holds a Master of Laws degree from the University of Toronto. Prior to joining the Faculty at Carleton University, Professor Milanovic practiced labour law in Canada for approximately a decade. He has participated in litigation at all levels of Canada's court and administrative law systems and in landmark international trade and human rights litigation in the United States of America. He has also testified before federal and provincial parliamentary committees on both domestic and international matters.

Professor Milanovic's paper will look at the impact of Parliament's having added section 65.12 of the BIA and section 33 of the CCAA in 2008, which specified that the full force of the collective agreement remained in effect during an insolvency proceeding. His essay will review the status of collective agreements in bankruptcy law prior to the reforms and analyze the incentives created by the reforms by examining new case law

and conducting interviews and a survey of insolvency professionals. His research will be used to determine if the amendments have unduly interfered with or prevented the successful rescue of businesses subject to an insolvency proceeding.

The \$20,000 scholarship, to be shared by Professors Hunter and Milanovic, is named after **Hon. Lloyd Houlden**, Q.C., a distinguished retired Justice of the Court of Appeal of Ontario. It is awarded annually to support "an original analysis of innovative ways to improve the insolvency system, a historical analysis of particular features of the system or an exploration of any other insolvency-related idea." Authors from any part of the insolvency community – practicing trustees and lawyers, as well as academics and students – are eligible to apply.

## CHAIR'S MESSAGE

s we take a look back on a cold spring and the early dashing of all hopes towards a Canadian Stanley cup finalist, let us bask in the knowledge that at least the CAIRP team has been working hard on many important projects on behalf of its members. Here is a small sample of the projects.

#### » Strategic Plan

The Strategic Plan Committee presented a draft of the Strategic Plan to the Board at its February 2012 meeting. Following discussions with the Board on the priorities and strategies of CAIRP, the committee will present to all members the final Strategic Plan, as approved by the Board, at the Annual General Meeting in August at the Annual Conference to be held in Banff Alberta, from August 14th to 17th, 2012.

#### » Governance

In August 2011, given the extensive time devoted by both the Chair and the Vice Chair as well as other volunteers, the Board directed that a comprehensive review of governance matters must be undertaken. The Board convened an adhoc Governance Committee, co-chaired by **David Howe**, CIRP, the CICA representative on the Executive, and **Larry Prentice**, FCIRP, Past Chair.

The committee has been working to understand the different responsibilities, tasks and roles undertaken in the past by the Chair, the Vice Chair as well as by the staff and the volunteers at large. A report on its findings has been submitted to the Board and any resulting changes to our by-laws to implement recommendations approved by the Board will be presented for approval by the members at the Annual General Meeting.

#### » Legislative Reform

In accordance with the requirements of the Bankruptcy and Insolvency Act (BIA), September 2014 will be the time for the next review of Insolvency Legislation. In preparation for this, CAIRP has named **William**Courage, FCIRP, representing the consumer aspects, to identify the issues within the BIA, which are of key importance to CAIRP and its members. Within the next few weeks, a member with a commercial practice will be named to identify the issues within the BIA and other insolvency legislation, including the Companies'

Creditors Arrangement Act (CCAA), and Wage Earner Protection Program Act (WEPPA) to identify the commercial issues. This will ensure our continued advocacy of a fair, transparent and effective insolvency system and restructuring

administration throughout Canada allowing all of our members to continue to provide the best solutions to financially challenged individuals and businesses whilst maintaining the highest degree of professionalism.

Through its Executive Committee and the President of CAIRP, CAIRP continues to maintain its positive working relationship with the Office of the Superintendent of Bankruptcy through continued dialogue on issues of importance to all stakeholders of the Canadian insolvency system. In addition, CAIRP is working to create and develop new relationships with other departments, such as the Canada Revenue Agency (CRA) through the renewal of its CRA Liaison Committee.

In addition to legislative reform, CAIRP must look to the future of our profession. An important first step was accomplished by the October 2010 signing of the Memorandum of Understanding with the OSB, whereby the administration of the Insolvency course and its materials was returned to CAIRP. But as an association, we must not stop there. In effect, to ensure that our future as a profession is maintained, the New Members Committee was created.

In the last few months, not only have they prepared their first action plan and held their first face to face meeting, they were also introduced as a committee to the Executive Committee of the OSB at the end of April 2012. Our President Mark Yakabuski and the undersigned also attended this meeting. We can all be proud of their accomplishments as a committee. Let us all find time to encourage our new members, as they are our future. Look for the introduction of this committee by their Chair, Julie Mortreux, in this Newsletter.

## **New Members Committee**

- » As an independent committee, providing support to the CQP Committee to improve the process for the 2013 exams;

## **COP UPDATE**

he CQP is a vibrant program with continuous development. As of the end of the first quarter of 2012, work is nearing completion on the first of the quarterly updates planned for the Core Knowledge Course which will reflect changes in legislation and jurisprudence as well as implementing suggestions received from members. The updating and revision of the Introductory Course, in preparation for adding it to the online platform, is also well underway. The course material review is approaching completion. Next on the agenda: review of the assessments for the course. Finally, the updating and revision of the Insolvency Administrators Course has also begun, with content updates being the first priority, to be followed by development work on the assignments and the creation of an expanded exam question bank.

Exam development is progressing on schedule. To aid in the development of new questions for the Core Knowledge Course, CQP has begun to work with a doctoral law candidate from the University of British Columbia. Our goal is to expand the number of

questions available for the Core Knowledge Exam with her assistance, to the extent that we are able to offer the exam more than twice per year.

The second Core Knowledge Course exam was held at the end of March. Forty-four of the 62 candidates who sat the exam (71%) succeeded, qualifying them to progress to the Applied Knowledge Course and join the 104 articling members already at this stage in the CQP. As a result, we anticipate a larger than usual number of candidates to challenge the first writing of the CQP national insolvency exam (CNIE) in October. All candidates who have been in the course for a minimum of 6 months, have accumulated the required number of experience hours (2,400) and feel ready to challenge the exam will qualify.

Work on the first CNIE is also on schedule, with the Exam Board focusing on tailoring the exam to meet the expectations set by the Competency Profile for new CIRPs, as released early in 2011.

#### **Notice to the Profession:**

The Board has readmitted into general membership, Mr. **Bruno Marchand**. In

doing so, the Board has carefully considered whether Mr. Marchand is, as required by section 11.01 of the CAIRP by-laws, "suitable and desirable in the opinion of the Board for admission to the Association as a general member". Mr. Marchand was formerly a member of CAIRP but resigned when a complaint was received about his conduct. Mr. Marchand's license was suspended for two months, from August 1st to September 30th, 2010, as a disciplinary process resulting from a complaint by the Superintendent of Bankruptcy. This complaint never questioned the honesty and integrity of the trustee, but rather raised concerns about inefficiency and not closing files promptly. The Board also considered Mr. Marchand's subsequent conduct where it appeared that files were being closed promptly. In the circumstances, the Board concluded that Mr. Marchand is suitable for readmission.
